Session Overview

The 1st Regular Session of the 75th Colorado General Assembly adjourned on May 7, 2025. Hicks & Associates is pleased to present this report summarizing legislative activity and key developments from the session.

Heading into the session, the 2024 election results left some uncertainty. Despite efforts, Democrats were unable to secure a supermajority in the Senate or increase their margin in the House. The Senate remained at a 23–12 split, while Republicans gained three seats in the House, narrowing the divide to 43–22.

The session officially convened on January 8, 2025. As is typical, over 120 bills were introduced on the first day—many originating from interim committee work. During the opening week, leadership from both chambers and Governor Polis laid out their priorities. The Governor delivered his seventh State of the State address, reinforcing the administration's goals.

Democrats, who still control both chambers, focused on key issues: the cost of living, budget constraints, workers' rights and wages, public safety, school funding, and environmental protection. A recurring theme in their messaging was safeguarding Colorado's progress from potential federal interference.

Governor Polis also emphasized two distinct priorities: cutting regulations to make Colorado more business-friendly (as the state is ranked the sixth most regulated in the country) and ensuring any changes to unionization processes involve meaningful compromise between employers and employees.

Legislative Activity

A total of 657 bills were introduced during the 2025 session—335 in the House and 322 in the Senate—down from 705 the previous year. Each legislator may introduce five bills, though interim and majority-sponsored legislation often expands that number. Of these bills:

- 171 were postponed indefinitely, including several that died on the calendar.
- 221 bills were signed into law by the Governor as of May 14, with more expected in the coming weeks.





Bills passed in the final 10 days of the session have an extended timeline, allowing the Governor **30 days** to take final action.

State Budget

Budget pressures loomed large this year. While the state saw revenue increases last year, this year presented a **\$1 billion shortfall**, forcing difficult decisions and casting a shadow over nearly every policy discussion. The deficit also led the General Assembly to cancel all interim committees to cut costs.

Political Dynamics

Since Democrats gained full control of the Capitol, the business community has often found itself on the defensive. In response, industry groups have formed broad-based coalitions to push back against or amend overreaching legislation—an approach that proved successful again this year.

Key Legislation Impacting the Construction Industry

HB25-1001: Enforcement of Wage and Hour Laws

Summary: Modifies state wage and hour enforcement statutes.

Impact: Introduced in response to the Governor's veto of HB24-1008, which focused solely on the construction industry. HB25-1001 applies more broadly to all employers. From the outset, the business community agreed that employees deserve to be paid fairly. A broad coalition worked successfully to amend the bill, mitigating many of its unintended consequences.

HB25-1077: Backflow Prevention Device Requirements

Summary: This bill clarifies who is authorized to work on backflow prevention devices, effectively restoring the workforce qualifications that existed prior to the passage of HB24-1344 (Sunset Review of the Plumbing Board).

Expanded Impact & GreenCO's Role:

HB25-1077 was a critical piece of corrective legislation, made necessary after a last-minute amendment to HB24-1344 threatened to disqualify over 90% of professionals performing essential backflow prevention work across the state. Had the language from HB24-1344 been allowed to stand, it would have dramatically disrupted operations for landscaping, irrigation, and maintenance businesses by shrinking the qualified workforce, delaying projects, and increasing costs.

GreenCO immediately recognized the threat to its members and sprang into action. Throughout the legislative interim, GreenCO:

- Convened stakeholder meetings with regulators, legislators, and affected industry groups.
- Provided technical expertise to lawmakers unfamiliar with the practical implications of the language in HB24-1344.
- Mobilized member voices to ensure that the real-world consequences of the policy change were clearly understood.

Thanks to GreenCO's sustained advocacy, HB25-1077 successfully reverted the statute to its prior, workable form—ensuring continuity for thousands of professionals and





protecting public health through proper backflow management. This fix not only preserved jobs but safeguarded vital water infrastructure maintenance activities statewide.

HB25-1113: Limiting Turf in New Residential Developments

Summary: This bill expands Colorado's ban on nonfunctional turf to include apartment and condominium properties, further tightening water conservation requirements in new residential developments.

Expanded Impact & GreenCO's Role:

As water conservation remains a top policy priority in Colorado, legislation like HB25-1113 reflects growing pressure to eliminate traditional landscaping elements—such as turf—in favor of low-water-use alternatives. However, the bill was introduced amid a broader crisis: the state's acute housing shortage and the complex balance between environmental goals and practical landuse planning.

GreenCO played an essential role in shaping the final version of this legislation. As the voice of Colorado's landscape, nursery, and irrigation industries, GreenCO brought grounded, technical insight to the table. Over the interim and throughout the session, GreenCO:

- Held numerous meetings with legislators, environmental groups, and agency staff to explain how turf restrictions affect project design, installation timelines, and long-term property maintenance.
- Proposed and secured multiple amendments that helped preserve landscape functionality, flexibility in design, and practical implementation strategies.
- Framed industry concerns in terms of both environmental stewardship and housing attainability, strengthening their credibility and resonance with policymakers.

The version of HB25-1113 that passed reflects a more balanced approach, thanks in large part to GreenCO's efforts. While the bill imposes new limits, it also contains critical exceptions and clarifications that ensure landscape professionals can still provide beautiful, functional, and sustainable outdoor environments.

HB25-1272: Construction Defects & Middle-Market Housing

Summary: Establishes new rules for construction defect claims in multi-family residential buildings.

Impact: Years in the making, this bill aimed to address a top industry priority. While compromises were reached, the final version still drew mixed reactions. Some in the industry remain uncertain about its long-term effectiveness—but its passage represents meaningful, if imperfect, progress.

HB25-1286: Protecting Workers from Extreme Temperatures

Summary: Would have created temperature thresholds requiring protective measures for outdoor workers.

Impact: Strongly opposed by the construction industry and broader employer coalition, the bill raised legal questions due to Colorado lacking a state-run OSHA. It was postponed indefinitely in its first committee without testimony. Sponsors intend to revisit the issue next year, so this topic remains active.





HB25-1300: Workers' Compensation Benefits Proof of Entitlement

Summary: Expands employee choice in selecting physicians from the approved workers' compensation provider list.

Impact: Despite amendments addressing some concerns, the business community opposed this bill due to potential unintended consequences for employers. The Governor expressed reservations, and last-minute changes delayed implementation dates in hopes of avoiding a veto.

SB25-005: Workers' Protection & Collective Bargaining

Summary: Eliminates the requirement for a second election to approve union security agreement clauses.

Impact: The Governor had made clear that he would only support this bill if it included compromises from both employers and unions. That compromise never materialized, yet the bill passed. A veto is anticipated, though political pressures related to 2026 ballot measures may complicate the decision.

SB25-018: Online Search of Sales & Use Tax Records

Summary: Directs the Department of Revenue to make sales tax licenses and exemption certificates searchable by name and federal identification number.

Impact: Part of ongoing efforts to simplify Colorado's complex sales and use tax system, this bill aims to increase transparency and streamline administration.

SB25-046: Local Government Tax Audit Confidentiality

Summary: Establishes confidentiality standards for third-party tax auditors and introduces penalties for violations.

Impact: Many local governments contract with third-party auditors to perform tax reviews. This bill ensures better oversight and accountability for those entities and builds trust in the audit process.

SB25-185: Claims Against Construction Professionals

Summary: This bill would have expanded homeowners' ability to bring negligence claims against construction professionals—including subcontractors and design professionals—regardless of whether they were the original or subsequent owners.

Expanded Impact & GreenCO's Role:

SB25-185 posed a serious threat to Colorado's construction industry by creating new avenues for litigation and increasing the legal exposure of subcontractors who are already held accountable for construction defects under existing law. If passed, it would have significantly increased insurance costs and legal risk for GreenCO's members and other skilled trades.

From the moment the bill was introduced, GreenCO's engaged in an intensive advocacy campaign that included:

- Dozens of meetings with lawmakers and coalition partners
- Detailed legal analysis and testimony preparation
- Direct member engagement and grassroots coordination

GreenCO also collaborated with general contractors, engineering firms, and trade associations to ensure a unified front. Their efforts culminated in a strong showing of





opposition, which ultimately led to the bill dying on the House calendar—it lacked the votes to pass and was never brought to a final vote.

This outcome was a clear and hard-earned victory for the construction industry and a testament to GreenCO's credibility, influence, and the power of industry coordination.

SB25-306: Performance Audits of Certain State Agencies

Summary: Requires performance audits of the Air Pollution Control Division and the Division of Unemployment Insurance.

Impact: Colorado has been a national leader in regulatory action on climate change and employment issues. This bill, supported by the business community, introduces greater accountability for the state agencies responsible for implementing those rules.

Other Notable Issues: Interim Planning

With no interim committees convening this year due to the budget shortfall, preparation for 2026 becomes more complex. Hicks & Associates will remain engaged over the summer, monitoring ongoing stakeholder discussions and early bill drafting efforts.

Conclusion

Overall, the business community notched more wins than losses in 2025. The continued formation of coalitions, clear communication, and focused advocacy were key to success.
